MATATIELE

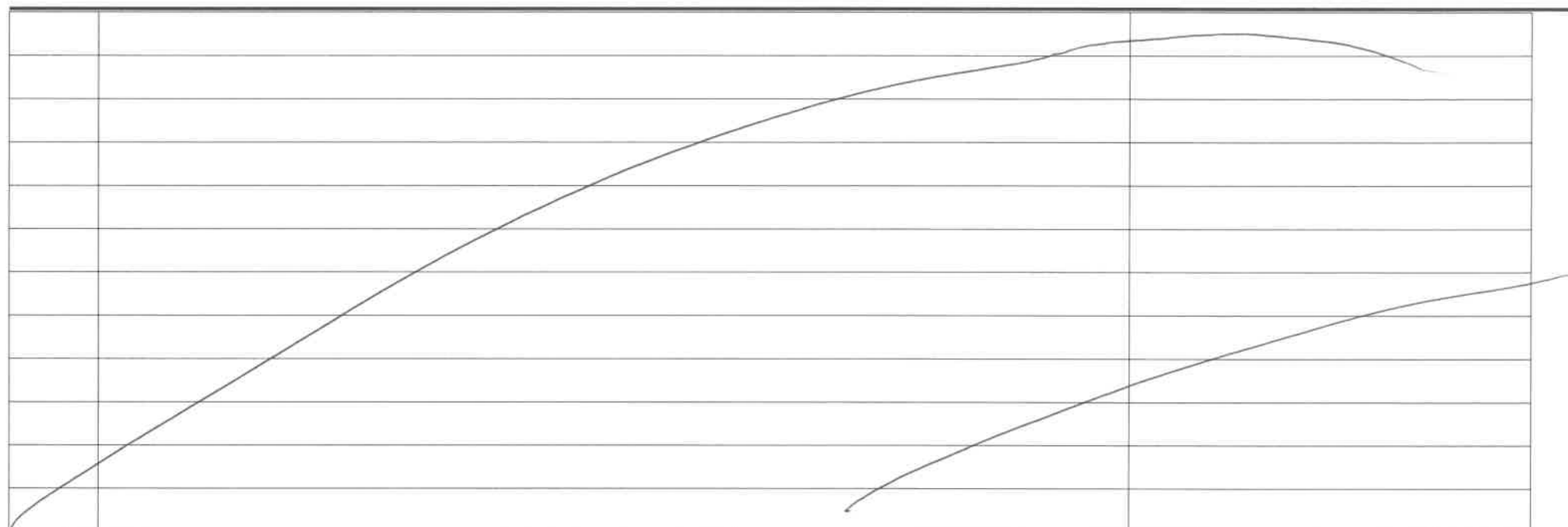
